Note: Heritage Road is currently closed for works access.  13/09/24 LC- Existing speeds support a 20mph speed limit – including on Cornwallis Avenue. Due to de-illumination of the existing signage required and illumination of some, the scheme will cost of approx. £100,000. APC to confirm if this is something they wish to proceed with.  22/10/24 LC – KCC are to investigate if a village wide

LC could look into double yellow lines but these are subject to a TRO which currently costs £3000 and so I would suggest adding any other problematic areas to make it more cost effective. The pavement is not new and does not take a straight path and so is very difficult to navigate in the dark: it is almost	Addition of street lighting to Dorman Ave S.	20.11.23 – APC would like this to be addressed under future development planning and funded by S106 funds. 22/10/24 LC – Street Lighting have provided APC with an outline design and quotation to install 10 lamp columns.
